

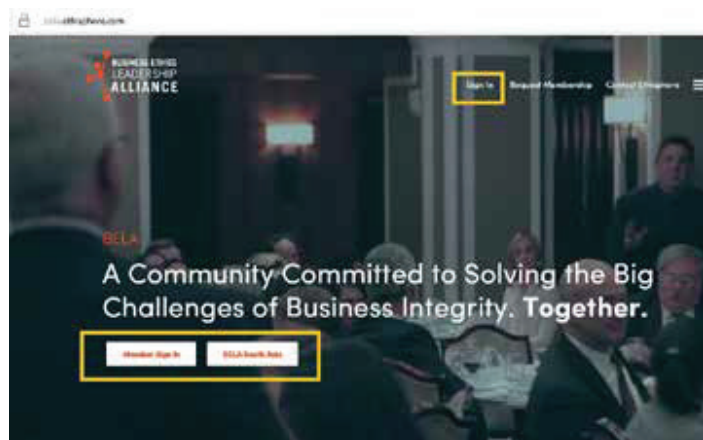
About

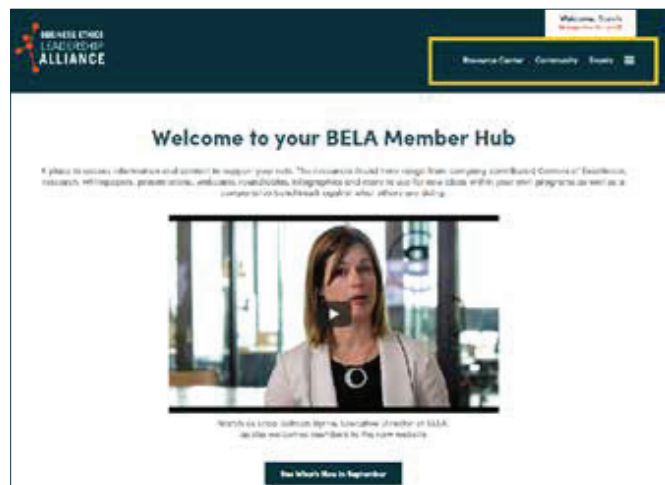

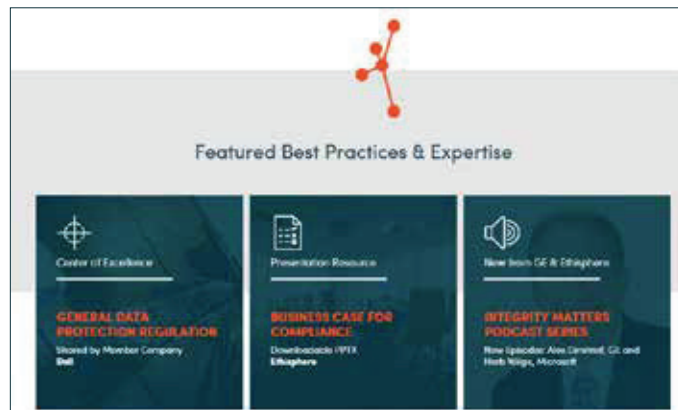

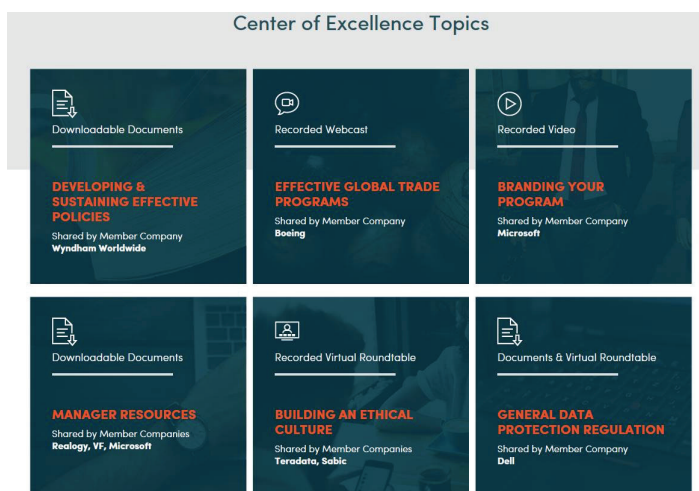

Centers of Excellence



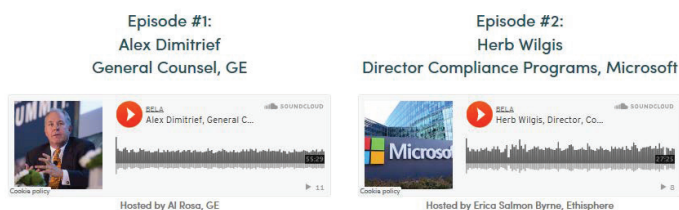

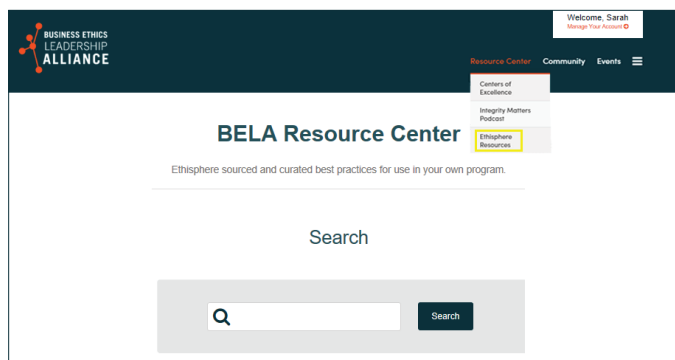
Integrity Matters Podcast



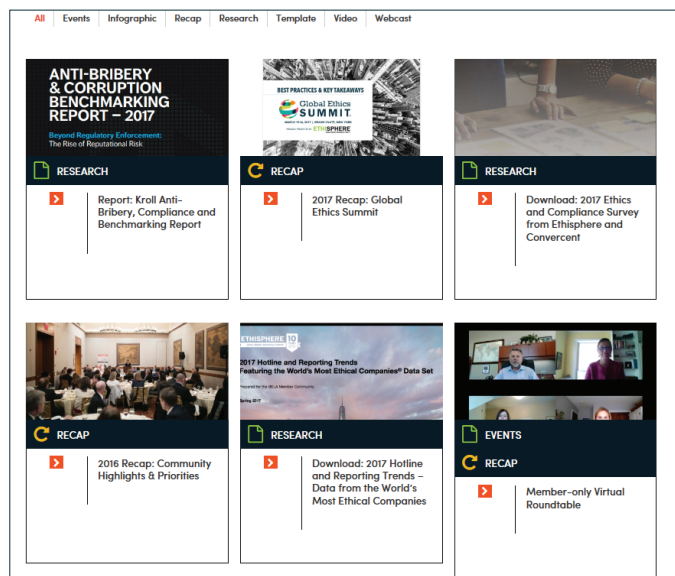

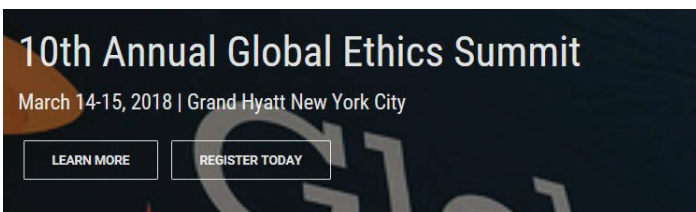
